The COSCO monthly hybrid meeting was held on January 12 excellent reports. Additionally, the He provided an in-depth report on how Translink is addressing issues that are of concern to seniors. Translink does ongoing determination about which, if any, eliminated. As walking longer distances may be an issue for some seniors, Kevin assured the group that access to facilities of importance to seniors would be a major consideration prior to moving or removing a stop. Removing a stop would have the potential to increase the speed at which a route could be completed. There are six washrooms that are to be installed in the next year, which will be helpful for many. At this time there has been considerable discussion about which stations to locate them at and if they would be inside or outside of the fare paid zones. Although the idea of free transit for seniors was raised the details of the potential funding shortfall that Translink will face in the coming years would make this possibility unlikely.

Electric vehicles are actually a part of the potential funding shortfall. Translink receives a portion of the gas tax and as gas use goes down so does the amount of funding they receive.

Translink management is also looking at the issue of riders, particularly seniors having to step up onto buses. Apparently, there are steps that can be taken to make buses stop at ground level to allow for easier access for everyone and these are being looked at.
